- If your hospital has or is trying to obtain magnet status, remind your supervisor that demonstrating staff participation in continuing education is vital to securing and keeping magnet status.
- Be ready with a plan that shows who will cover for you while you are attending the conference.
- Offer to share a room to reduce hotel expenses.
- Elaborate on what you plan to get out of attending and how that will benefit your job.
- Create a schedule to show the people who will cover your tasks while you're away.
